

Cancellation, Terms and Conditions

Application process

To register complete Form 1 which will be available via a link on our website. This will be live at 9am on 9th December.

Once we have accepted your application you will be sent Form 2 and the GP form to complete. These forms need to be completed by 31st January at the latest.

Once you have returned all your forms we will be able to confirm that you have a place.

Insurance

Please note that the price for Tour includes basic travel and medical insurance. Medical insurance is not provided for pre-existing conditions. All participants must have a valid GHIC. More information will be provided when you sign up.

Pocket Money

The recommended amount of pocket money for Europe Tour is £100 plus an additional £60 in shekels for Gesharim.

Currency cards and a small amount of Euros are preferred.

Cancellations

If a participant wishes to cancel their place on a programme they must contact LJY-Netzer in writing to jess.s@liberaljudaism.org

If an applicant cancels their place on Gesharim:

Before 19th March 2025 a full refund less the Administration Fee;

On or after 20th March 2025 and before 30th May refund of amount payable less £700;

On or after 30th May no refund will be given (any outstanding balance remains payable).

If an Applicant cancels their place on Kayitzr:

Before 31st January 2025 refund of 100% of amount payable less the Administration Fee;

On or after 31st January 2025 and before 19th March 2025 refund of 100% of amount payable less Deposit and the Administration Fee;

On or after 19th March 2025 and before 20th April refund of 50% of amount paid (or payable) less Deposit and the Administration Fee;

On or After 20th April and before 30th May refund of 20% of amount paid (or payable) less Deposit and the Administration Fee;

On or after 30th May no refund (any outstanding balance remains payable).

Gesharim Tour is subject to a minimum of 30 participants. If we do not have sufficient participants by 19th March, we will cancel the Programme and refund your deposit.

The Israel Tour component will take place dependent on FCDO guidance permitting travel to Israel for non-essential purposes. The decision of whether it will go ahead will be made by 19th March. If the decision is made that it cannot go ahead, you will receive a refund less a

maximum of £200. We will endeavour to limit this loss, and will refund as much as we are able to recover.

In the event that the FCDO guidance changes prior to 19th March and subsequently changes back between 20th March - 20th July, to advise against 'all but essential travel', Gesharim Tour would not go ahead. You will receive a refund less a maximum of £700. We will endeavour to limit this loss, and will refund as much as we are able to recover.

Force Majeure

We regret we cannot accept liability or pay any compensation where the performance or prompt performance of our obligations under our contract with you is prevented or affected by or you suffer any damage, loss or expense of any nature as a result of 'Force Majeure'. In these booking conditions, 'Force Majeure' means any event which we could not, even with all due care, foresee or avoid. Such events are likely to include actual or threatened war, riot, civil strife, terrorist activity, industrial dispute, natural or nuclear disaster, adverse weather conditions, fire and all similar events outside our control.
